Global Business Company [GBC] - A GBC is a company resident in Mauritius for tax purposes and can benefit from various double taxation treaties which Mauritius has entered into with several countries. In order to obtain treaty benefits, the company is required to establish its tax residency in Mauritius and must demonstrate that central management and control of the company is located in Mauritius.

Authorised Company [AC] - The AC is a company whose business activities and control & management are outside of Mauritius, thus considered as a foreign company for tax purposes. This type of company does not have access to the Double Tax Avoidance Agreements network of Mauritius.

Funds Administration - A fund is a structure whose operations depend on the notion of risk diversification and whose activities include investing money in a portfolio of assets. The Securities Act of 2005 essentially defines two types of Funds: Close-ended Funds, also known as Private Equity (PE) Funds, and Open-ended Funds, also known as Collective Investment Schemes (CIS).

VAITOS - The Virtual Asset and Initial Token Offering Services Act 2021 (the "Act" or "VAITOS Act 2021"), provides for a regulatory framework for new and developing activities regarding Virtual Assets ("VAs") and Initial Token Offerings ("ITOs") in Mauritius.

A Virtual Asset ("VA"), according to the VAITOS Act 2021, is a digital representation of value which may be digitally traded or transferred, and may be used for payment or investment purposes, but does not include a digital representation of fiat currencies, securities and other financial assets that fall under the purview of the Securities Act.

Variable Capital Companies - The VCC Act 2022 provides a comprehensive legislative structure for those who wish to set up different types of funds within one legal entity. A variable capital company ("VCC") is incorporated under the Companies Act and may carry out its business through sub-funds and special purpose vehicles ("SPV").

Investment Dealer - The authorized activities under an Investment Dealer (**Full-Service Dealer excl. Underwriting**) License are as Follows:

- Act as an intermediary in the execution of securities transaction for clients;
- Trade in securities as principal with intention of reselling these securities to the public;
- Give advice on securities transaction; and
- manage portfolios of clients.

Investment Adviser - Section 30 of the Securities Act 2005 and Rule 5 of the Securities (Licensing) Rules 2007 made under it allow for Investment Adviser Companies to be set up and licensed in Mauritius, under 3 broad categories:

Types of Licences

- Investment Adviser (Unrestricted)
- Investment Adviser (Restricted)
- Investment Adviser (Corporate Finance)

Global Headquarters Administration - The GHA licence enables multinational companies to set up their regional administration, procurement and accounting offices within the Mauritius International Financial Centre (IFC).

Global Treasury Activities - The Mauritius Global Treasury (GTA) Activities Licence enables multinational enterprises (MNEs) to set up or relocate their regional treasury management functions to Mauritius.

Global Legal Advisory Licence - This licence is applicable for international law firms interested in establishing regional offices in Mauritius to provide legal advisory and international arbitration services to global business clients.

Such law firms will be eligible for a 5-year corporate tax holiday. The application is made under section 77 of the Financial Services Act 2007.
